Date: Saturday & Sunday, August 4th & 5th, 2012

Location: The Wallenpaupack Area High School Gymnasium which is highly visible and located right on Route 6, 1 mile east of Hawley, PA

Set-up time will not begin until Noon on August 3rd and this will be strictly enforced. Limited porters are available, please tip them accordingly.

Shut-down time August 5th - Items off tables by 7:30pm, vacate building by 8:00pm, this will be strictly enforced.

We will once again have available complimentary soda, donuts, and coffee during set-up as well as a light buffet at approximately 4:30/5:00 p.m. on Friday evenings.

Due to power limitations we will once again be asking for your cooperation in restricting usage. Keep in mind this is a modern facility with good lighting and thanks to the consideration of all we have had no problems in the past.

As a non-profit organization this show is run by our member volunteers and the proceeds used to benefit various organizations in the region including historical societies, national register and other historic properties, area libraries, and so on.

Due to space restrictions we strongly recommend getting your booth deposit in right away. As in the past we will do everything possible to accommodate any special request but cannot guarantee booth location. No pets allowed.

TERMS OF CONTRACT

In consideration of the acceptance of this contract and rental of exhibit space, the undersigned agrees to the following:

1. To insure your space, **YOUR DEPOSIT MUST BE RECEIVED BY June 1st**, however, we recommend returning this completed contract application and booth fee as soon as possible as space will be available on a first come, first served basis. Contracts received after the June 1st date will be charged a \$50.00 surcharge, If space is not available when your completed contract application and deposit are received, your money will be refunded unless you wish to be placed on our Waiting List. In case of Exhibitor cancellation before July 1st, deposit will be refunded. **No contract will be accepted after July 1st.**
2. Electricity will be available at no charge, however, we reserve the right to limit usage as needed (as has been done in the past) due to the service limitations at this facility. Heavy duty electrical cords and power strips with surge protectors must be used.
3. For those exhibitors requiring tables, a nominal fee of \$12.00 per table will be charged for vendors requesting them. Tables must be reserved and paid for in full in advance. Tables will be 8' in length, 30" wide. In order to maintain a pleasant appearance, tables must be draped to the floor unless merchandise will be attractively displayed underneath.
4. The Wayne, Pike, Sullivan County Antiques Dealers Association and the Wallenpaupack Area School District assume no liability for loss to the Exhibitor from fire, theft, accident, or any other cause, but will to the extent practical furnish security and fire protection for the duration of the Show.
5. In the event that the Show is unable to open or is canceled for any reason after July 15th, no booth and/or table fee(s) will be refunded.
6. Show is limited to antiques and collectibles, No Reproductions. All jewelry must be in a case. All tables must be draped to the floor. No Pet allowed.
7. Include photo of your booth for publication and so we can see your specialty for show.
